VIII. JOINT NECROLOGICAL ADDRESS

WHY DEATH IS AN IMPORTANT SYMBOL IN THE PHILOSOPHY OF FREEMASONRY

To the outside observer some masonic art and renderings can seem morbid. To the uninitiated the repeated use of symbols of death, like the scythe and the skull and crossbones can give people pause. Some of that imagery may have given rise to the idea of Freemasonry being some sort of cult.

Like all Masonic symbols this imagery must be understood to see how it fits into the philosophy of Freemasonry. The obvious thing to point to is the legend of the temple builder that most Master Masons are familiar with. It is argued there is a greater reason why Freemasons are so concerned with death that we put those images on our Tracing Boards.

The answer is simply, Equality.

Death has been said by poet, philosopher and Freemasonry to be the "Great Leveler." Everyone who is born will one day pass away; it is inevitable. When you start from that premise, we are all the same. Whether you are the richest man in the world or have nothing but your footprints to remind the world you are there, when it comes to death, we are all the same. Death comes for us no matter our station in life, our religious belief, our gender or our race.

Freemasonry deals little with what comes after death. It is an event which we all must face. That is our own mortality, that Freemasonry focuses in on. Freemasonry, on a fairly broad level, does not care what you believe in what awaits you after death.

Freemasonry's philosophy deals with how you live your life up to the time of your passing. Almost universally being a good person brings you reward after your death. Freemasonry creates a structure to remind every mason what those qualities are that makes a person "good" regardless what religion you may practice.

Therefore, as freemasons we should always strive to walk upright before the World. That when the day comes for each of us, we will be remembered as a "Good and Upright Mason." (Source Masonry Today 2017)

XVII. INAUGURAL ADDRESS OF THE NEWLY INSTALLED GRAND HIGH PRIEST

The newly installed Grand High Priest M. E. Companion Juanito P. Abergas delivered his inaugural speech:

"Let me just share with you this afternoon some of my thoughts on Lodge Management that we can all address as it is equally interchangeable and compatible with our situation in our Royal Arch Chapters.

First, Lodge/Chapter membership growth, and Second, lodge/Chapter participation.

In the matter of Lodge membership growth, it seems to me that the most common and perennial problem that confronts a lodge is how to increase its membership. In this regard, there are at least two circumstances that work against the rapid growth of lodge membership, compared to other secular organizations. Firstly, in our Blue Lodge Freemasonry is the prohibition by our rules and regulations against inviting persons to join the fraternity. Secondly, in the Royal Arch Chapter, one simply applies for membership because he was invited, or sought membership on his own volition.

The other circumstance that works against the growth of membership is the unanimity rule which requires that after a petitioner shall have applied on his own free will and accord, the approval by Lodge/Chapter of his petition requires the unanimous vote of all members present. This has always been the rule on admission and to relax the rule is so fraught with grave dangers that the character of Masonry might change with a relaxation of the rule. You and I know, of course, that in some occasions, we do not always get a unanimous ballot. Membership in the York Rite bodies will depend on the number of petitioners admitted in any particular Chapter

But apart from looking outside the fraternity for membership, why not instead look inside? Let me explain.

On the matter of membership. A Master, albeit, the Excellent High Priest then ought to manage the activities of his Lodge or Chapter; and not do it alone.

One segment of the membership of a Lodge/Chapter that, in my observation, has not been properly harnessed, is that group which we refer to as PM/PHP by virtue of their having occupied the Oriental chair at one time. They are a rich source of ideas.

PMs/PHPs are, by and large, a sensitive group. Having been in the center of things during their term they long to be given that recognition that they believe they are entitled to, even if it is just a minor role in degree work. The point is, we should not neglect the participation of our PM/PHP in lodge/chapter activities. They should, as a matter of policy, be asked to participate. In the manner, a Master/High Priest can develop a core group of dedicated members that can assist him in managing the concerns of his lodge and get everyone else to participate.

My hope is to see all PMs/PHPs playing active roles in their respective lodges/chapters. The sitting Master/High Priest can avail himself of the experience or expertise of this group, or he may not. The is for him to ponder upon and decide.

It is possible of course that you may not be able to please every member and some may even go so far as to criticize your programs but learn to take each in stride. Divided, we can accomplish nothing; united we will not fail our fraternity. X. REPORT OF COMMITTEES

The Right Eminent Grand Commander then announced the several working committees to render their reports if any:

1. REPORT OF THE COMMITTEE ON CONSTITUTION AND BY-LAWS.

R.E. Companion Manuel Liam C. Garcia reported that the committee was in the middle of reviewing the current draft of the proposed Constitution and by-laws of

all the Grand Bodies when suddenly M.E. Companion Danilo C. Datu, Sr. dropped his working tools. The Committee had to drop the review and defer the submission of the draft for approval because it had to take over the workload of doing the proceedings and all the other duties of the Grand Secretary/Recorder. He then set the date for the Committee to submit the approved draft within 6 months starting November 2019.

XI. PRESENTATION OF RESOLUTIONS

- S.K. Michael Benjamin submitted a joint resolution of Plaridel and Rizal York Rite bodies on establishing a central governing body for the Grand York Rite. The Acting Right Eminent Grand Commander referred the said resolution to the Jurisprudence Committee to study the proposed resolution.
- 2. S.K. Companion Crispulo M. Fernandez, Jr., PGC reiterated that the actual Grand Officers are supposed to open the Grand Commandery as passed in the last Grand Conclave. Secondly, he suggested that the Grand Line Officers should be the ones to be appointed as supervisors to be able to show their involvement in the Grand Bodies of the Rite and to be more visible in the local subordinate bodies. Lastly, he asserted that the Constitution and bylaws should come out within 6 months to give time for everybody to review and to comment with ample time before the Grand Sessions on October 2020.
- 3. S.K. Evaristo A. Leviste, Right Eminent Department Commander made a motion to support the candidacy of S.K. Jack M. Harper, current Department Commander (South Central) and PGC of Texas, for the position of Grand Captain General of the Grand Encampment of KT of the USA on its next Triennial in 2021. It was seconded by S.K. Jomel Dennis L. Maranan. The motion was duly approved.
- 4. S.K. Manuel Liam C. Garcia, Grand Recorder put forward a motion to grant the title of "Honorary Past Grand Commander of the Grand Commandery of the Philippines" to S.K. Sidney J. Leluan III and S.K. Jeffrey A. Bolstad. It was immediately seconded by S.K. Nestor V. Tampol, PGC. The motion was duly approved amidst the applause of all the Fraters present.

XII. KEYNOTE ADDRESS OF THE RIGHT EMINENT GRAND CAPTAIN GENERAL

S.K. Jeffrey A. Bolstad, Right Eminent Grand Captain General delivered his keynote address:

"REGC, REDC, Distinguished guests, SKs all. I bring you greetings from SK Jeffrey Nelson, Most Eminent Grand Master GEKTUSA. We are just a little over a year into this triennium and we are "amping" up our retention efforts for membership. Retention is the real key to every Commandery having success.

We have a GE Membership committee working hard on this, to give you the tools and support to win the battle in keeping your membership engaged and attracted to being a Templar.

My talk is going to be a little different than what you are used to hearing from someone in my position. I like to give leaders something they can take home with them and apply to their position, wherever you happen to be in your leadership continuum. Some questions for you to ponder

What is Templary?
What do we do?
What is our mission?
What is our vision?
Who is Jacques DeMolay?
Who is Jesus Christ?
Why are you a Templar?

See, Templary is different than any other appendant Masonic body. It's different than any organization I know of. We are men of God and warriors for Christ.

If I were to ask you your philosophy of life, could you tell it to me? Most of us don't think about our life philosophy, the operating set of beliefs that drives our worldview. Our philosophy of life comes out of us in subtle ways: the attitude we wake up with in the morning, how we treat other people, how we approach a new situation, the things we spend our time, energy and money on.

It's worth taking a moment to examine our life philosophy...It's like a GPS for our life. You put your destination into your GPS and it gives you the directions you need ...to get where you need to go.

As Templars we know the best source of that life philosophy, that GPS, is Jesus Christ. Scripture says He is the Word of God come down from heaven. He is God's revelation of the way our lives should be lived.

You see, Jesus' entire philosophy of life was based on love.

I am constantly amazed how many Christians miss that truth. There's a reason for that, of course. Maybe we have never really listened to the teachings of Jesus. In Luke 6 He says: "But to you who are listening... love your enemies . . ." "To you who are listening . . ." The key takeaway is—-Not everybody is listening

Listening means we're open to change. Listening to God means being obedient to God. —THERES a word we don't like. Obedience. So, Jesus knew that only a few people may really listen to his message.

But to those who are listening, he offers a philosophy of life that provides not only hope, but salvation as well.

Jesus calls us all to serve him. We have to be listening. And obedient. All of us here have been called to leadership. Servant. Leadership. FISHERMEN at SEA of GALILEE

Here's a quote for you to consider "Love isn't how you feel. It's what you do."

A couple of Navy Seals wrote a book called "Extreme Ownership" In this book the point is made that there is no such thing as a bad platoon, only bad leaders.

The same can be said for Commanderies. The real question is, why are we facing such a dearth of leadership? And what do we do about it? I would go so far as to say we don't have a membership problem. We have a leadership problem.

My theory is that 60 years ago when Masonry was at its peak, membership-wise, we had good leadership because most all of the community leaders belonged to the lodge. Maybe they joined because it was the popular thing to do, but we benefited from their leadership.

Fewer and fewer of the leaders in the community are joining us, and even those that do are rarely involved other than paying their dues.

The upshot is that we end up with men in positions of leadership who have no idea about what leadership looks like, or even how to go about developing it.

Poor leadership sometimes comes about because of us. We promote our friends or relatives into positions of leadership, when a better choice is ready and willing. So, we pass over the best guy for the spot because we like our buddy "OI Joe" and we want to

see him get to be the Commander. Or we practice law and we know a lawyer in town who would really like to be Grand Commander. and we like to take care of our fellow lawyers when we can, so despite the fact that there are much better choices for the job, we appoint the lawyer friend.

Now we've created a situation where the best guy for the spot gets discouraged, and we never see him again. Meanwhile, "Ole Joe" just fills the spot because he wants the title...and probably really wants the title of Past Commander...and nothing happens and the Commandery continues to deteriorate. Or even worse, the power associated with the position goes to his head and he drives everyone away with micromanagement and high-handed edicts. And then he appoints one of HIS buddies to the bottom of the line, without any regard to leadership quotient, because he has no idea what it is!

Or even worse.... some PGC wants to control everything and so he gets his puppets elected into the line so he can pull the strings. Or a Grand Secretary is up to the very same skullduggery! It's a banana republic!!! And that brings us to this very day.

Our leadership situation is directly proportional to our membership situation. We do a decent job creating new Knights, but our efforts at retention and restoration are bad to non-existent.

I have never considered myself an expert on leadership, but I am an ardent student of that subject. Many years ago, I set out to do what I can to help those who are in leadership positions or to help those who have a desire to be in leadership.

So, what do we do? First, I think we need to check our personal friendships at the door of the ballot box and vote for the good of the order, not for the good of our buddy. Pray about it!!! It's ok to call on Jesus Christ for discernment in every matter! Templary is one of His important ministries!!!

Second, since whoever we elect probably has little to no leadership experience, we have to gently help them develop as they move up the line. Make sure to approach them out of love and care, not in a way that makes them feel like you are "telling them what to do."

All of you here are in some sort of leadership role. If you are a good leader, you are always working on getting better at it. Leaders are readers. We have a great leadership class that you should take. If you've already taken it, take it again. Bring your up and coming SKs to the class.

So, let's talk about leadership. And further, what is known as SERVANT Leadership. That stuff that was invented by Jesus. Really, I've got nothing new for you today. Everything you need to know you already know. Because really all it is, is just doing the right thing. Treat people the way you want to be treated. Be the boss you wish your boss would be. Be the father you wish your father could've been more fully for you. Be the neighbor you wish your neighbor would be. Be a co-worker you wish your co-worker would be. So really everything you need to know you learned in kindergarten. Don't hit. Share. Meet needs.

We clearly know the difference between servant leaders and self-serving leaders. Servant leaders go to an organization because they're committed to the wellbeing and development of other men...self-serving leaders? I go to an organization or institution because I want privilege, power, and prestige, only for myself.

It's never been clearer. And what's happening now is that people are choosing servant leadership because they recognize it's the right thing to do. To serve other people.

So that's what I do. I teach people about stuff that they learned a long time ago. So, I don't instruct, I remind. I remind people. Everything I talk about I stole all that stuff that has been around for centuries. I'm a thief, I admit it.

The world between stimulus and response is the world of character-- you know, doing the right thing even when you don't feel like it. Winning all those battles between what you want to and what you should do. That's what leadership is all about.... just doing the right thing.

It's the right thing to do to have patience and self-control with people. It's the right thing to do to be kind. It's the right thing to do to listen. It's the right thing to be humble. The right thing to be respectful. To meet needs —that's what you signed up to do dad, boss, coach, mentor...you signed up to meet needs.

It's all leadership is - it's just doing the right thing. Character and action. So, this stuff's been around a long time.

But a leader, to be a leader, must have followers. You're not a leader unless there are those who volunteer to follow you. You cannot force someone to follow you. They have to choose to follow you. Leaders inspire people to follow them, they inspire people to go in the direction they are going.

Leadership then is how do we inspire and influence people to action? And excellence? "Do it, or else" isn't really effective these days in case you haven't noticed.

So that's what leadership is - Can you inspire and influence a group of people to excellence? Can you get them to own the mission? Can you get them to create excellence in your Commandery?

So, leaders get in the game and they meet needs.

And that's why character is so important because character, that's that person you are in the dark when nobody is looking, the real you. And in the end, leadership development and character development are one.

You want to be a better leader? You got to work on your character.

---Revolutionary war story---

What's leadership? Leadership is just doing the right thing even when you don't feel like it. What's character? Doing the right thing even when you don't feel like it. Especially when you don't feel like it.

So, it's the right thing to do to hold your members accountable to excellence, to grow them, to listen to them, to appreciate them, to encourage them. To inspire them. All of the things that we're talking about, those are character.

We're wrong to think people can't change. People can change. We all have people in our lives who we love to be around. They light up a room when they walk in. And we all know those who only light up a room when they leave. But they can change! But we're wrong to think it's easy.

It doesn't happen reading books and watching PowerPoint Slides. Nobody ever became a better leader by reading a book.

Leadership is exactly like being an athlete or a musician. It's exactly analogous. Anybody ever learned how to swim by reading a book? I think you can learn about swimming. Anybody ever become a great golfer watching Tiger Woods videos? Well, you can learn about golf. Anybody ever become a great musician studying piano history?

I mean, if you want to be a better golfer, what have you gotta do? You've got to start practicing this stuff over and over because you can't improve unless you change by definition.

We need good leadership developed at the grassroots level in order to have good leadership at the Grand level. Leadership is a skill set that needs to be practiced, and Masonry has more opportunity to practice than any other venue I know of. One final story. Story of the two stonemasons. Go to first One ...how do you like your job? I like my job I've been working on this wall for as long as I can remember. The stones are heavy the work is backbreaking it's monotonous I stand in the scorching hot sun all day and I don't know if I'm even gonna finish this wall in my lifetime. But it's a job, it pays the bills.

You get to the second guy and ask him "how do you like your job". He says I love my job...I'm building a cathedral. Sure, I've been building this wall as long as I can remember. sure, the stones are heavy and the work is backbreaking and I Gotta stand out here in the scorching hot sun all day and it's monotonous and I don't even know I'm gonna finish this wall in my lifetime. But I'm serving my fellow man ...building a cathedral.

What they do is exactly the same.

This guy might even be a champion stone layer the only difference is that only one of them knows why he shows up at work every day. and the guy who knows why ...does not see himself as any more or less important than the architect or the guy doing the stained-glass windows or the landscaper ...they are all contributing to building something that they believe in... that is bigger than themselves

A leader is somebody who can put into words that which does not exist yet. The leader is the one who stands there and says in beautiful crystal-clear words and he describes that cathedral that hasn't been built in words so clear that others can take that image and they can pass it on to others.

Why are you working so hard? Because I believe in it, we're building a cathedral. What cathedral? Let me tell you.

Are you describing your cathedral or are you just telling people about the wall you're building? The reason that everybody showed up here is because together we're gonna build a cathedral. We are all contributing to a world that we would rather live in.

There are leaders and there are those who lead. Leaders hold a position of power or influence. Those who lead inspire us ...they serve us....and we follow those who lead not because we have to but because we want to.

So, I hope you will leave this room today with your GPS programmed. Not the GPS in your car or your phone, but the GPS in your head and heart. I pray that you have

programmed it with the love of Jesus Christ. That way, as a SK, you will reliably represent Christ and make a difference in the world.

Before I sit down, I promised SK Jack Harper the REDC-SD that I would mention to you that he is a candidate for my job, REGCG. Right now, he is the only candidate running and I suspect he will probably be unopposed. I sure wouldn't want to run against him. Already he's been formally endorsed by 25 Grand jurisdictions. But you can look him up online and if you have any questions for him, give him a holler.
