Tampol, PGHP. There being no errors or objections, his report was approved, subject to the usual audit.

2. REPORT OF THE GRAND HIGH PRIEST

Companions all, good morning, and good evening.

A year ago, when I took up the responsibility of Grand High Priest, I was hopeful that towards the middle of this year, 2021, the situation following the pandemic would improve in this part of the world. I was hopeful that the technology and medical breakthroughs at this time would be able to counteract the spread and avoid what happened during a similar pandemic 100 years ago. Unfortunately, it wasn't so. Even at the present time, a multitude of countries are still exhausting their best efforts in combating the virus and any semblance of normalcy is still far ahead.

The stance of the Grand Chapter, as well as the Grand Council and Commandery of the Philippines, were to make the safety of the companions and Sir Knights its utmost priority. Companions, please consider that the Philippines is not a first world country. Our medical sector is substandard in its care and is easily overwhelmed by the sheer number of patients that require undivided attention each day. The medical facilities and equipment available in the country are far from desirable. The pandemic has upended countless meetings and events, but the unfortunate reality is that lives have been lost, including those of our brethren. In the past three months, Masonic brothers who succumbed to the virus are too many to enumerate- even those admitted in the most advanced hospitals in the country.

It is for this reason that we, in the Grand York Rite bodies, have decided against face-to-face meetings. There were times early this year when the consideration of lifting the ban on stated meetings was discussed. Two months later, the second wave of COVID loomed over the country. In hindsight, it was the right decision to limit face-to-

face interactions. It would not sit well with your grand chapter officers if a York Rite stated meeting was the cause of a companion contracting the virus. It would be much worse if his family got infected as well and would have to face the detrimental effects brought about by it. Remember companions, as your grand officers, we look out for you as brothers should. It is for your benefit and well-being that we aim to open our doors once again when the time is opportune for us to gather safely and responsibly.

This year has been challenging to say the least. As I have said, I was hopeful last October. Somehow, the inactivity was demoralizing and will compel you, at a time like this, to shift your focus and priorities. Everyone here has felt the difficulties in areas such as their work, business, family and even as simple as day to day living. We must accept the possibility that this may drag on for another year. Your Grand Officers strongly feel that it is in the best interests of the body to adapt to this current setup. Therefore, we have decided that the best way to move forward will be to directly engage the local chapters, councils and commanderies VIRTUALLY, until that day comes when we are able to conduct meetings in full confidence of our brethren's safety. We plan to visit and HOST virtual meetings for ALL active and in-active chapters, councils and commanderies at least once every quarter. Virtual fellowships with the active bodies and greeting the companions and SKs may also be an option. Plans are currently underway to meet and sort out solutions for the problems that the inactive bodies are facing, especially areas in the Visayas region.

On the internal side of the Grand York Rite bodies, there are several items that need to be accomplished, namely:

1. Updating the constitution and by-laws of the 3 grand bodies
2. Updating the government compliance for non-profit organizations documents of the Grand York Rite of the Philippines.
3. Creating a more efficient flow and operating procedures for the Grand York Rite administration office.
4. Fine-tuning the ritual of the grand chapter. We have no "official" grand chapter ritual. What we are using is the one from the general grand chapter, which is supposed to be supplemented with details to cater to a particular jurisdiction.
5. Updating of the diplomas, certificates, patents, and forms of the Grand York Rite Bodies.
6. Establishment of a "supplies shop" in the Grand York Rite office.

We have started with the 2 edicts that was issued just recently for the establishment of 2 positions, the Assistant Grand Treasurer, and the Grand Auditor. The

aforementioned items are the main agenda of the Grand York Rite bodies as we move forward. These are items that are always neglected but of great importance as these are fundamental materials- materials that make a strong foundation to a strong, well-functioning masonic body. It is a tall order, but it is with hope that these items I mentioned to be completed at the soonest possible time.

I am hopeful for better times more sooner than later. Know that your Grand Chapter will be more active with you Virtually to renew the interest and dedication of our beloved Order.

Thank you for your time, Companions, especially to our guests from abroad who took the time to be with us under irregular hours. May all of you, your families and loved ones be safe and healthy.
