Sir Knights,

The Grand Commandery of Knights Templar of the Philippines forms part of the Grand York Rite of the Philippines. We have shared accountabilities and responsibilities in the Grand York Rite of the Philippines with 2 other Grand Bodies namely the Grand Chapter and the Grand Council.

With this set-up, I am establishing a few Committees who will assist the Grand Commander in dealing with the Grand York Rite of the Philippines.

- 1. Committee on Administration This will handle matters involving employees & support staff to run the office, Government registrations, Financial aspects (e.g. updated Bank account, GCash, Investments, Insurance etc) and Utilities (e.g. Telephone, Internet, Electricity, Water etc).
- 2. Committee on Building and Office Use This will look into the lease agreement with the Grand Lodge of the Philippines, Adherence to the Building Code, Renovations, Other York Rite Building or Land donated and mutual office space design with other Grand Bodies.
- 3. Committee on Asset Management This will take into account all assets of the Commandery used for ceremonials, documents, tokens etc and common office equipment shared with other Grand Bodies.

- 3. Committee on Asset Management SK Alvan Joseph Balazo, SK Emmanuel Bravo, SK Victorino Floro III, SK Jesher Go, SK Evaristo Leviste, SK Orlando Mabutas, SK Dexter Ng, and SK Nestor Tampol.

The Committees are encouraged to discuss among themselves their Chairman and Vice-Chairman who will report their initial organization structure during the 61st Grand Conclave. To ensure that these Committees will organize themselves in time, I am appointing temporary leads to get the ball rolling. For Administration – SK Victorino Floro III; Building and Office Use – SK Nestor Tampol; and Asset Management – SK Alvan Joseph Balazo.
